N.B:-

- Temporary Rules of procedure for conduct of Election to TCA, 2019 will be followed for conduct of Election (*uploaded on website of TCA [www.tcalive.com](http://www.tcalive.com)*).
- Copy of any one of the following certificates (*self attested*) to be produced at the time of submission of Nomination paper as proof of age & identity of the candidate:-
  - (a) Age proof – Birth certificate or Admit card or PAN card.
  - (b) Identity proof – Adhaar card or Electoral photo ID card
- The candidate & proposer must be a Member of General Body of TCA as per final electoral list. A copy of valid photo ID card (*self attested*) of the proposer to be submitted along with the Nomination form.
- The voters will have to produce valid original photo indentity card for casting vote.
- Nomination form shall have to be submitted before the Returning Officer by the Candidate or his proposer in person.
- Notice for withdrawal of candidature shall have to be submitted either by the Candidate or his proposer in person.
- In case there is no contest, the candidate who has filed nomination for any office bearer or position shall be declared as elected uncontested immediately after stipulated time of withdrawal.
- All the candidates shall have to follow Code of conduct for Election to the Apex Council of TCA which is uploaded in the TCA website [www.tcalive.com](http://www.tcalive.com).
