The Hon'ble High Court of Tripura has given its verdict dated 16/01/2024 on the cases WP (C) 471 of 2023 and WP (C) 473 of 2023 dated 16/01/2024. Its paragraph 25 reads "I deem it fit to appoint an Electoral officer to conduct the election of TCA. Accordingly, I request Mr. Kishore Ambuly, IAS (retd.) as an Electoral officer to conduct and hold election of the Tripura Cricket Association. Mr. Ambuly is requested to complete the entire process of election within a period of 1 (one) month from the date a copy of this order is furnished to him".

In compliance to the said order and in consultation with Shri Kishore Ambuly, the Committee of Administrators of Tripura Cricket Association, in administrative accordance, does hereby

- 1) convene a General body meeting of Tripura Cricket Association on **15/02/2024** for taking up of the election mandated by the Hon'ble High court of Tripura and
- 2) appoint Shri Kishore Ambuly as Electoral Officer and
- 3) Shri Sushil Ch. Saha as Returning officer to assist the Electoral Officer for conducting the election as a special event as per order of the Hon'ble High Court of Tripura for electing the Office bearers and Council member of Apex Council as per TCA constitution updated and registered under Registrar of Cooperative Societies of Tripura w.e.f 18/09/2023.

Remuneration to conduct the election would be given as usual and as paid in the previous event of election of TCA.
