The said meeting was called to order after ascertaining that the requisite quorum turned-up.

With permission of all the members present, the notice convening the meeting having already circulated was taken on record.

The Chairman of the meeting congratulated all the members present and addressed the house.

#### Agenda - I

#### Interim Budget 2024-2025 (April to September, 2024)

The period of the Financial Year 2024-2025 is for the time period April, 2024 to March, 2025. The Annual General Meeting of Tripura Cricket Association will be held in the month of September, 2024. Consequentially an Interim Budget for the priod 01-04-2024 to 30-09-2024 will have to be passed by the General Body under the recommendation of the Apex Council. Accordingly, during the Apex Council meeting on 29-04-2024, the agenda was taken up for discussion and it was resolved to pass an Interim Budget for INR 44,32,02,569/- (Forty Four Crores Thirty-Two Lac Two Thousand Five hundred Sixty Nine only) with the details given in Annexure - I.

The matter of suspense account appeared in the last budget 2023-2024 has been recorded in the interim budget in a foot note and it was resolved to give effort to book the expenditure in proper head as early as possible and do other needful actions.

It was further resolved to get the interim budget passed by the General body by inviting a Special General Meeting, budget being a General Body jurisdiction event as per constitution.

#### Agenda - II

#### Appointment of Statutory Auditor for the F.Y. 2023-2024 and Internal Auditor for the F.Y. 2023-2024 and 2024-2025

It has been resolved that the Statutory and Internal Auditors may be engaged from the panels of registration under CAG by inviting "Expression of Interest (EOI)" and on the basis of performance record and offer of annual payment.

#### Agenda - III

#### Appointment of Consultant for Labour Cess and GST related issues

It has been resolved that the Consultant for Labour Cess and GST related issues including all other applicable taxes may be engaged by inviting "Expression of Interest (EOI)" and on the basis of performance record and annual payment.

#### Agenda - IV

#### **Revision of Financial guidelines of TCA**

There was a General Body decision on 02/03/2024 for enhancement of the Preparation money, Coaching grant, match money etc. of all Clubs and Sub-divisional Cricket Associations of Tripura Cricket Association after examining the rates of enhancement proposed by Shri Sani Saha (Refer the minutes of the meeting 02/03/2024).

The matter has been examined by looking into the previous progression of enhancement in the Apex council meeting and it was resolved to adopt the proposal of enhancement of rates as laid in the General Body meeting w.e.f the cricket season 2023-2024 with the details given in Annexure – II along with an observation that the next enhancement will be allowed not before 01/01/2027.

#### Agenda - V

#### Policy for House Rent allowance for employees

An observation was placed before the Apex Council that there are a few staff who lives in his own house but take house rent allowance which is eligible for employees who actually lives in rental residence. To check such practice, it was resolved that any staff getting house rent allowance would have to give a monthly self-certificate statement that he actually resides in a rental house and he has no residence of his own in the head quarter of operation for his service.

#### Agenda - VI

#### Policy for House Rent allowance for employees

An observation was placed before the Apex Council that some of the employees are continuing in service beyond qualified age as prescribed in the Service Rules of TCA 2020. It was resolved that the provision of the Service Rule of TCA 2020 shall be strictly adhered to before giving continuance of service for such Jayanta Aug

#### Agenda - VII

#### Frame a guideline for employees to disburse allowance for assigning to Election Duty of TCA **Apex Council election**

Few of the staff posted in the head office of TCA were assigned with additional task to assist the Returning Officer during the Election of Apex Council of TCA on 15-02-2024. In this respect, it has been decided to provide a lump-sum allowance to those staff. The three signatories of Office Bearers are hereby authorized to finalize the same time to time reasonably.

#### Agenda - VIII

#### Deal with one doubtful loan against term deposit in SBI, Agartala branch

An observation was placed before the Apex Council that while making the EPF payment through online on 12/03/2024 from State Bank of India, Agartala branch, which was pending for last 05 months view on CD account made by Shri Diptangshu Chowdhury who deals with the Tally software, it has been revealed that one loan account number 00000042108974720 was created on 24/07/2023 for an amount of Rs. 28,80,00,000/- and some other linked transactions. Shri Pradip Kanti Sen, Accounts Manager of TCA (retired) is only the resource person who deal with operation parameters of taking loan, interlinked transaction, CD account or other accounts under Account section of TCA, was asked to clarify the matter but he had verbally intimated that he had no knowledge about this loan.

Thereafter, a team consisting of Shri Tapan Lodh, Honorary President, Shri Basudeb Chakraborty, Honorary Treasurer, Shri Tanmay Mitra, Office Manager (presently In-charge of Accounts section as an additional responsibility) and Shri Pradip Kanti Sen, Accounts Manager of TCA (retired) had moved to SBI, Agartala branch and it was gathered that Shri Tapash Ghosh, previous Secretary and Shri Joylal Das, previous Treasurer of TCA had taken a demand loan from FD on 24/07/2023 on a justification of the requirement of immediate expenditure of liabilities. The rate of interest for that FD was 6.75% where the interest against the demand loan was 7.75%. Practically it has been observed that this loan was utilized for payment for a small amount during the last 7-8 months. TCA has some small sized FD which would be matured in the next 4-5 months in other banks. Trend expenditure during the next 4-5 months can be met from funds available from those matured FDs.

Therefore, it has been resolved that the loan account may be closed. It has been noted that the loan has been requisitioned & sanctioned without obtaining authorities from Apex Council or General Body as per the provision of the Memorandum of Association and Rules & Regulations (amended 2023) of TCA clause number 7(5) (f).

Shri Tapash Ghosh should had restrained himself from taking step for such huge investment plan. The General body had further taken decision on 20/07/2023 for directing the Secretary, Vice-President and Treasurer to refrain from coming to office till a special investigation team (SIT)starts its functions on certain allegation against them. Further, Shri Tapash Ghosh was decided to be declared as functus officio in the General body resolution on 20/07/2023. Official processing for the loan was not found.

Therefore, it was resolved that any loss of TCA in this loan investment should be ascertained by an expert professional. Shri Tapash Ghosh and Shri Joylal Das should be appropriately fixed with responsibilities against loss and unauthorized exercise of power. The bank authority had already been provided with a copy of Memorandum of Association and Rules & Regulations (amended 2023) of TCA. It should not have accepted that the loan requisition from signed by Shri Tapash Ghosh and Shri Joylal Das as Secretary and Treasurer without having support of Apex Council or General body decision.

A communication from TCA should be made to appropriate Bank authority for reporting against this apparent mis-exercise on the part of the bank.

#### Agenda - IX

#### Enhancement of Coaching grant and travelling allowance of Women's cricket run by TCA

The matter for enhancement of the Coaching grant, travelling allowance etc. of Women's cricket under Tripura Cricket Association has been examined by looking into the previous progression of enhancement in the Apex council meeting.

It was resolved to approve the enhancement w.e.f the cricket season 2023-2024 as mentioned below with an observation that the next enhancement will be allowed not before 01/01/2027 -

• Participation Money - INR 1,20,000/- per cricket season.

• Match money - INR 15,000/- per match.

• Travelling allowance - INR 7,000/- per match. (only for Melaghar match)

#### Agenda - X

#### **Decision about rented flat**

The requirement of a residential flat at Agartala in view of stay of outstation members, players, coaches etc. was found economical and essential.

Therefore, it was resolved that TCA will keep one rented residential flat in Agartala town area with economic rates as decided earlier and ensure a good utility management.

#### Agenda - XI

#### Induction of One Member Shri Sani Saha (Udaipur) as Invitee Member of Apex Council

It was felt necessary that one member from sub-divisional cricket association for organizing and coordination of matters related to TCA functioning in the South sector has to be invited in Apex Council meetings. Accordingly, it was advised during the Special General Meeting held on 02/03/2024 that Shri Sani Saha of Udaipur Cricket Association may be appointed for the purpose.

Therefore, it has been resolved to induct Shri Sani Saha of Udaipur Cricket Association as an Invitee to all the Apex Council meetings for the current tenure of 3 years.

#### Agenda - XII

### <u>Policy for disbursement of yearly Coaching grant to Sadar CC/PC, new affiliation of CC/PC, renew of affiliation of existing Sadar CC/PC</u>

After a threadbare discussion it was resolved that a committee will be constituted to frame a policy for new registration and/or renew of registration of Coaching/Play centers of Sadar Sub-division. The said committee will also recommend the rate of enhancement of participation money, other financial benefits & logistic support towards Coaching/Play centers of Sadar Sub-division.

Side by side, it was decided to provide INR 15,000/- (Rupees Fifteen Thousand) only per cricket season as participation money to all Coaching/Play centers those who actually participate in local junior cricket tournaments under Sub-divisional cricket associations.

In addition, it was also discussed that the Blood Mouth and Polestar clubs have applied for registration of Coaching/Play centers under TCA of their clubs. It has been noted that there is a rush of youth's cricketers in Ramnagar and Krishnanagar areas. The Blood Mouth and Polestar clubs have taken initiative to organize young players for cricket playing through coaching. TCA may allow registration of those clubs from the date they are in a position to participate in the Sadar Under 13 and Under 15 Cricket Tournaments run by TCA. In the meantime, provisional registrations to Blood Mouth club and Polestar club for Coaching center under TCA are hereby given w.e.f 29-04-2024 which will be reviewed after 1 (one) year if the club fails to participate in the tournament within one year.

#### Agenda - XIII

#### **Engagement of Coaches in Sadar CC/PC**

Depends on the actual requirement of coaching, re-deployment of coaches of TCA will be made to meetup the demand of actual crisis areas throughout the state.

#### Agenda - XIV

#### Compulsory engagement of Online Scorer in local tournaments of sub-divisional cricket associations

During the cricket season 2021-2022, TCA introduced the online scoring in all tournaments directly run by this association which is helping the TCA to monitor the actual performance of players and status of the matches of the respective tournament.

After a detailed discussion on the agenda, it was resolved that from now onwards, to monitor all the matches which are being conducted by the sub-divisional cricket associations in their locality, compulsory online scoring will be introduced and the payment for the purpose will be borne by the concerned sub-divisional cricket association.

Further, it was also resolved that manual scorer for all matches being conducted by the sub-divisional cricket associations in their locality will be optional, subject to availability.

#### Agenda - XV

#### Guest player (Men & Women) for the cricket season 2024-2025

For BCCI Tournaments, all state cricket associations including TCA are allowed to hire guest cricketers (the players who belongs to other state/from areas outside their jurisdiction) in Senior Men's squads (maximum 03 players) and Senior Women's squads (maximum 03 players) in every cricket season.

After a detailed discussion, it was resolved to invite "Expression of Interest (EOI)" after obtaining a report from the selection committee of TCA regarding the category of player both men & women as required for state team. The said players will be hired without any professional fee and/or remuneration except allowance, accommodation, transportation etc. as would be practicable for good management.

Further, it was resolved that the Expert Committee of TCA will finalize those players.

#### <u> Agenda – XVI</u>

#### Engagement of Strength & Conditioning Coach Miss. Harshitha Krishnamurthy for Senior and <u>Under 23 Women's teams of TCA during the cricket season 2024-2025</u>

During the last cricket season 2023-2024, TCA had engaged Miss. Harshitha Krishnamurthy as the Strength & Conditioning Coach of Tripura Senior Women's team and she performed well. She was also engaged with Tripura Under 23 Women's team on temporary basis. Show Bayank May T. Loch

On the basis of her last year performance, it was resolved that, TCA may re-engage her for both the teams as stated above. The three signatories Office Bearers are authorized to finalize the professional fee and other terms & conditions.

The opinion of the Expert committee constituted for finalization of the Guest cricketers will be recorded in this respect.

#### Agenda - XVII

#### Job extension of LDA (Accounts) and contingent staff of TCA

For the smooth cricket management, TCA appoints few contingent staff in head office or cricket grounds controlled by TCA purely on contract basis for 89 days with per day wages in one spell and review thereafter. The earlier service period of those contingent staff is over. Presently the domestic cricket tournaments are running full-fledged in all grounds under TCA and the work load in head office has also increased. Therefore, the service of those contingent staff would be required for this association for another spell.

#### Agenda - XVIII

#### Constitute different sub-committee for Annual Prize Distribution Ceremony of TCA

On 22-06-2024, TCA may conduct its long pending Prize Distribution ceremony. To organize the said event in proper manner with good management, few committees like Transport committee, reception committee, committee for refreshment, purchase committee etc. may be constituted. The three signatories of Office Bearers have been directed to finalize the same in consultation with other Office bearers.

#### Agenda - XIX

#### Policy for procurement of prizes for Annual Prize Distribution Ceremony of TCA

A policy for procurement of prizes, memento, replica etc. was resolved as below:-

#### Step - I

The prizes, memento, replica etc. should be selected by a committee as given below:-

- One Member from the Office Bearers of TCA

The President is responsible for making arrangement of disposition of matters related to any office bearers at the instance of any indisposition as per provision of the Constitution.

Therefore, a confidential assistant is to be provided with President's office. Such assistant should have skill for taking dictation and typing and also having knowledge of dealing files in offices, skill of drafting letters, taking notes, discussion of meetings and putting things in file and also have integrity. But the requirement of such staff may be part-time due to less work load. It is therefore, proposed that a part time daily rated staff may be engaged preferably from retired person dealing with high officials' public administration on part time/daily rated basis. If available or otherwise from others having minimum qualification knowing stenography and B.A in English tested on actual performance.
