In a first step, the Engineer-in-charge of TCA and its counter part of RKSCPL may sit and discuss in detail to find a settlement, if possible. Engineer-in-charge, TCA would conduct the meeting.

In second step, the Honorary Secretary of TCA accompanied with other Office Bearers of TCA and the MD, RKSCPL accompanied with his supporting officials may sit and try for the settlement.

Follow-up decision by either of the TCA and RKSCPL authorities may be taken combined or independently according to the outcome of the common trial for settlement as said.

The meeting ended with vote of thanks from the chair to the participants.
