Agenda – 6

Removal of anomaly of match money for Member unit of TCA for similar tournament i.e. J C Memorial Tournament

Tournament of the J C Memorial Club league organized under TCA could not be conducted during the 2022-2023 and 2023-2024 cricket seasons due to shortage of time for conducting all the scheduled tournaments and other programs.

J C Memorial Club League is a three days match tournament. It is the best exercise for players for induction into Ranji team. This is a general feeling among the members and former cricketers that Tripura cricketers have to be made better fit/skilled for expected better outcome in Ranji matches.

Taking due consideration to this view, the Hon. Secretary of TCA raised a proposal to give higher emphasize in conducting J C Memorial Club league in the current cricket session 2024-2025 and playable session 2023-2024 and for previous session 2022-2023 as a backlog.

The Apex Council resolved the enhancement of match money in its meeting dated 30-01-2025 and the General body have also approved this in its meeting dated 20-03-2025 in view of enhancement due to price rise.

Previous playable session tournament that will be played during this playable session backlog would involve similar enhanced cost. Therefore, it was proposed by the Hon. Secretary of TCA that the match money for previous season of J C Memorial Club league would be played during this current playable session may be allowed as enhanced rate as already approved as mentioned above.

Proposal being reasonable has been approved by the Apex Council and resolved that the match money of previous season JC Memorial Club League matches played during current playable season would be at the approved enhanced rate as follows:-

- The match money of participating club teams in J C Memorial Club League for the cricket season 2022-2023 enhancing to @ INR 25,000/- (Rupees Twenty Five Thousand) only per team per match day in place of earlier @ INR 15,000/-.
- The match money of participating club teams in J C Memorial Club League for the cricket season 2023-2024 is @ INR 25,000/- (Rupees Twenty Five Thousand) only per team per match day as already approved by the Apex Council vide meeting dated 30/01/2025.

However, the Apex Council has taken a decision that the resolution to play previous season J C Memorial Club League in current playable session as well as payment of match money as enhanced rate would be considered as a one time decision and cannot be referred as example for any other future cases.

Proposal to bear the cost of cricket clothings' (white) for the cricketers of affiliated clubs under TCA for day's format in J C Memorial Tournament

In view of the reason as stated in the agenda number 6 of the Apex Council meeting held on 20-06-2025, it was also resolved that the cost worth INR 40,000/- (Rupees Forty Thousand) only will be provided to the participating club teams in J C Memorial Club League for the cricket season 2022-2023 and 2023-2024 unitedly.

However, the aforesaid decision would also be considered as a one time decision and cannot be referred as example for any other future cases.

The maximum numbers of the representatives of the affiliated Clubs under TCA has placed a proposal to make few changes in rules of domestic cricket tournaments on & from the cricket season 2025-2026.

The said matter has been referred to the Advisory Tournament Committee to verify the proposal and place a report before the Apex Council.

It was resolved that the report of the Advisory Tournament Committee on the subject cited above will be placed in the next Apex Council meeting.
