Agenda – II

Induction of new Life Members under TCA.

It was resolved in the last Annual General Meeting held on 30/10/2024 to induct 100 numbers of new Life Member on the basis of estimate of expired earlier Life Members.

As follow-up action on the resolution of the General body, the Apex Council in its meeting dated 30/01/2025 resolved to call application by deciding on the information required in support of candidature read as,

Eligibility criteria: -

- The applications will be invited through local newspapers and TCA website.
- The applicants must be a resident of Tripura.
- The lower age limit for applicants is minimum 30 years as on 30/01/2025.
- The President and Secretary of the nearest affiliated Club of TCA or home Sub-divisional Cricket Association of TCA will jointly certify the names of the applicants in writing.
- Final list of 100 nos. will be made by the General Body of TCA through vote from the eligible applicants.

Membership fee :-

- INR 30,000/- (Rupees Thirty thousand only) as one-time life membership fee in the form of Demand Draft (DD) in favour of "*Tripura Cricket Association*", payable at Agartala, after selection.
- An earnest money amounting to INR 5,000/- (Rupees Five thousand) only in the form of demand draft in favour of "*Tripura Cricket Association*", payable at Agartala is to be given along with the application.
- The earnest money on non-selected applicants will be released within 3 (three) months after receiving application for release.
- The application form may be collected from the following offices of the affiliated member units of TCA or downloaded from the TCA website 'tcalive.com'.
 - 1) Udaipur Cricket Association.
 - 2) Teliamura Cricket Association.
 - 3) Dharmanagar Cricket Association
 - 4) Blood Mouth Club
 - 5) Cosmopolitan Club
 - 6) Sphulinga Club

The application with certification and DD must be submitted in person to the aforesaid offices only.

Candidatures of these 92 applicants were placed before the house for resolving induction of everyone as Life Members of TCA after due consideration of the house against everyone of the candidate/applicant through secret vote of the members present in the house, total 26 numbers inclusive of President. President being the chairman of the meeting did not cast his vote. All other 25 members had casted their vote either “ Yes” or “ No” vote against every one of the candidates or chosen not to caste any vote against any candidate. The voting was conducted by the President under his Chairmanship.

Candidates who secured majority of “ Yes” vote i.e. more than 50% of the total casted votes in every case have been declared to have been inducted as Life Member of TCA. Others who have got “ Yes” vote less than 50% of the total casted votes have been declared not to be inducted as Life Members of TCA.

On the basis of result of vote as stated above the following 81 (eighty-one) applicants have been resolved to be inducted as Life Members of TCA :-

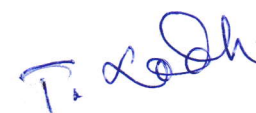
One case was reported that The Hon'ble Justice (retd.) Shri Arindam Lodh had telephonically communicated his willingness to become Life Member of TCA to the Hon. Secretary of TCA on the cut-off date before the cut-off time of receiving application. The formalities of application have been made thereafter. It was proposed that, being a person of high dignity, a sitting high court judge at that point of time, his candidature may be accepted and his induction may be considered by the house as a special and one-time consideration case. The house, however, hailed the proposal and unanimously resolved his inclusion/induction as one Life Member of TCA.

The process of induction of new Life Member invitation through notice no. F.29/TCA/AGT/PR/24-25/7472, dated, Agartala, 10/03/2025 was declared closed. Remaining numbers as per resolution of the General Body meeting held on 30/10/2025 added with more created vacancies would be inducted through fresh call afterward.

On request of a few members of the General body, the President himself had placed a proposal before the house to consider the induction of former Presidents of Tripura Cricket Association as Honorary Life Member of TCA devoid of voting right to TCA and not eligible to be elected as representative of Life Members to TCA also. If anyone of them opts for regular Life Member by contributing Life Membership fee of INR 30,000/- (Rupees Thirty Thousand) only, he may be inducted as regular Life Member of TCA with voting right and right of representation in TCA, if selected. The proposal was hailed by the General Body members and resolved YES on the proposal unanimously.

There being no other further business and/or no content to discuss.

The meeting ended with vote of thanks from the chair to the participants.
