The sealed tender can be sent through Registered post / Speed Post / reputed courier service up to 3 P.M on **22/08/2017**. No late receipt of sealed tenders after the stipulated time and date will be entertained, any tender received after the closing time for submission of tender shall be returned unopened.

General Secretary, Tripura Cricket Association, Agartala on payment of a sum of Rs. 5,000/- (Rupees five thousand) only for each work in cash (Non refundable) on any working day during office hours upto 3.00 P.M on **18/08/2017** on Submission of written application for the work along with documentary proof (in a shape of photocopy of self attested)

Valid PTCC/STCC/GST registration/ PAN card, Enlistment & valid license regarding engagement of workers in contract works from labour , Govt. of Tripura. Application for tender form may be submitted in the office of the Tripura Cricket Association, Agartala along with cost of tender form and other relevant papers up to 3.00 P.M on **22/08/2017**.

Receipt of application for issue of tender form will be stopped at 3 P.M. on **18/08/2017** and issue of tender forms will be stopped at 5 P.M. on **18/08/2017**.


