- The firm should have annual turnover of Rs. 5.00 cr. In last financial year.

Along with the quotation, the bidder should submit the following necessary official documents:

- Photo copy of PAN card duly self-attested.
- Photo copy of Service Tax clearance certificate duly self-attested.
- Photo copy of GST clearance certificate duly self-attested.
- Photo copy of Trade license duly self-attested.
- Photo copy of Official address of firm / manufacturer duly self-attested.
- Each supplier/Manufacturer should submit at least 2(Two) samples of each item with the quotation.
- Design & sample to be approved by the TCA authority before finalization of the tender.
- The Lowest Quotationer should deposit performance Security for an amount of Rs.30,000.00(Rupees Thirty thousand) only in the shape of Demand Draft in Favor of The Secretary, TCA, payable at Agartala from any Nationalized Bank.
