The sealed quotation will be received at the office of Tripura Cricket Association (TCA), Post office Chowmuhani, *on or before 30/03/2026 up to 03:00 pm* and *Quotation will be opened on the same date at 4.00 PM, if possible. Form should be download from TCA website www.tcalive.com up to 03:00 pm 30/03/2026. Cost of Form Rs.2000.00 (in the shape of DD of in favour of Tripura Cricket Association to be enclosed with the Tender Form.*

The Quotationers or their authorized representatives may remain present during opening the Quotations.

At the time of submission of Quotation, the following rules & regulations have to be followed:

- The rate should be quoted both in figure and words including all Taxes.
- **TCA Logo, Tripura Cricket Association and Not For Sale to be printed in each bottle. TCA logo may be fixed by sticker in the body of the bottle.**
- The quotation will be received in sealed cover with name of work written on the envelope addressed to the Secretary, TCA with quotationers postal address & phone number.
- **Earnest Money to be submitted along with quotation for an amount of Rs.20,000/- (Rupees Twenty Thousand) only** and if format of Rate quotation downloaded from TCA website www.tcalive.com cost of form Rs.2000/- (Two Thousand) to be also in the shape of Demand draft in favor of Tripura Cricket Association should be deposited from any Scheduled bank under RBI.
- Time for supply of Purified Package Drinking Water as and when required during the year 2026-27 will be intimated by TCA.
